- 2023 JANUARY** All large companies that are already within the scope of the NFRD
- 2024 JANUARY** Companies meeting two of the following three conditions—€40 million in net turnover, €20 million in assets, and 250 or more employees.
- 2025 JANUARY** For listed SMEs, excluding microenterprises
